#### Structure, governance and management

#### Type of governing document

The Forum is a charitable unincorporated association and the purposes and administration arrangements are set out in our constitution. Recognition as a Scottish Charity was gained on 20 September 2007. The constitution was most recently altered on 16 December 2010.

#### Trustee recruitment and appointment

The Forum's Trustees (Committee) are appointed or reappointed by the members at our annual general meeting. The Committee has the power to co-opt up to two members of the Forum to the Committee.

#### Objectives and activities

#### Charitable purposes

Our purposes, as recorded in our constitution, are to advance education through the promotion of a clear understanding in Scotland, Russia, and the countries of the Former Soviet Union, of the respective ways of life, history, heritage and the cultural and commercial activities and voluntary services of the said countries and through the creation of educational and cultural contacts of all kinds between the peoples of these countries.

## Summary of the main activities in relation to these objects

The Forum arranges a programme of lectures and exhibitions each year, publishes 'The SRF Review' twice a year, circulates a fortnightly information bulletin by e-mail and provides information through its website. The Forum rented premises to house a Russian cultural centre, the Scotland-Russia Institute, with rental and associated costs met for the first three years by a donation from Scottish and Newcastle plc, in June 2008. As well as meetings of the Forum, the centre hosts art exhibitions featuring works from or about Russia and the other countries of the Former Soviet Union, language classes and a library.

#### Achievements and performance

Summary of the main achievements of the charity during the financial period

Membership of the Forum was maintained, with a small increase in the number of members compared with the previous year. The Forum's activities continue to be focused on its cultural centre, the Scotland-Russia Institute, with many events attracting capacity audiences. The year's programme was enriched by an expanded programme of exhibitions and related lectures made possible by a donation from the Moscow-based Russkiv Mir Foundation. These included exhibitions of work by Russian and British artists on Russian themes, and an exhibition celebrating the legacy of Andrei Sakharov. The year's lecture programme ranged from the literary and visual tradition of Armenia to a series of talks on the changes in various aspects of Russian society in the 20 years since the end of the Soviet Union. To commemorate the 50th anniversary of man's first flight in space the Forum arranged a programme of visits in Scotland, mainly to schools and colleges, for the Russian cosmonaut Anatoly Artsebarsky. The library now contains around 2000 books. Classes in the Russian language for various levels of ability continue to be popular and are held thoughout the year. Through the good offices of the Forum, three Language Assistants were placed in Russian Universities and institutions of Higher Education. The Forum was active in supporting the teaching of Russian in schools, and has arranged successful 'taster classes' in a number of primary schools. Two issues of the Scotland-Russia Forum Review were published during the year and circulated to nearly 400 people and institutions. The weekly e-mail bulletin was circulated to around 800 members and non-members with information on events and activities relevant to the Forum's objects. The Forum's website continued to be extended and improved and is now the primary source of information about the Forum and its activities. A generous donation from a member of the Forum permitted the employment of a part-time administrative assistant during the year.

As a result of the surplus of £9773 in unrestricted funds for the year, the Forum held unrestricted funds of £29643 at the year end which will support the Forum's general activities in the coming year. Having met its commitment to funders to operate a cultural centre in Edinburgh for a minimum of three years to June 2011, the Forum held a total surplus of £8020 in restricted funds, which will allow it to complete the programme of exhibitions and events supported by the Russkiy Mir Foundation. In order to maintain reserves, and to continue to operate the cultural centre until the expiry of the present lease in June 2013, a modest increase in subscriptions was introduced from September 2011.
